## **NOTIFICATION**

Paschim Banga Society for skill development(PBSSD) is the nodal agency responsible for the execution of all short-term training interventions under Utkarsh Bangla. PBSSD hereby amends the existing Utkarsh Bangla scheme further in the view of operational issues while implementing the Utkarsh Bangla scheme at the ground level for an effective programme performance.

## Part -1

The following have been modified/inserted in the Standard Operating Procedure (SOP) in continuation to the earlier order No 608 – TET (Estt)/ 2E-07/2016 dated  $18^{th}$  June 2018 , order no -734-TET (Trg)/ET/0/2E-24/2019 dated  $29^{th}$  November 2019 and I/119766/2021 of TETSD dated 10th February,2021 of the Utkarsh Bangla scheme document

A. Training Cost: PBSSD would follow the rates as mentioned in the table below for all OP-NOS Courses:

Category	Rate-Utkarsh Bangla (INR/Trainee/Hour)
Category-I	49.00
Category-II	42.00
Category-III	35.10

- B. For the entire state funded non-institutional interventions under the Utkarsh Bangla Scheme, the payment to TPs will be disbursed as per the existing payment milestones governed by earlier order No I/119766/2021 of TETSD dated 10th February,2021.
  - C. This order is prospective and shall be applicable for future trainings only.

## <u>Part - 2</u>

As per the existing guidelines there is a provision of final Installment Pay-out (Third Installment @ 25%) as per the slabs against the placements done and verified to the Training Providers only.

While it is observed in the past that despite of provision of final pay out options to the Training Providers under Utkarsh Bangla scheme, the desired placement numbers as a quantifiable outcome was not

achieved.

In order to achieve higher number of placement numbers as per the scheme guidelines, this needs additional modifications to existing Utkarsh Bangla scheme guidelines for pay-out against the placement slabs.

After careful consideration of the matter, the revised modifications to existing guidelines are as follows:

- a. Industries/ Industry associations and placement aggregators shall be allowed to place the trained candidates other than the existing Training **Providers**
- b. The final Instalment Pay-out as per the slabs under Utkarsh Bangla scheme shall be also extended to the entities mentioned in Point (a) above against the final payment for placements which was only applicable to Training Providers as per previous guidelines

c. Under the proposed modifications to the existing guidelines for placement pay out, the Training Provider would not have any claims against the placement related payment.

d. The payment would be done to the Industries/ Industry Associations/ Placement Aggregators as per criteria of successful 3 months' post training placement and tracking as per the existing guidelines/ definition of placements.

This has concurrence of the Finance Department vide UO No: Group B/2021-2022/0076 dated 25/12/2021 and has approval of the competent authorities in PBSSD and TET&SD Department.
