NOTIFICATION

Sub: Empanelment of Training Providers to carry out the Short-Term Trainings under State Specific Scheme.

PBSSD invited proposals through the PBSSD.GOV.IN portal from experienced National Training Providers presently implementing skill development programmes under the DDU-GKY, PMKVY and Sagarmala schemes at the national level, as well as from experienced Training Providers (LOI Mode) having prior experience in conducting placement-linked skill training programmes. Eligible Training Providers were required to have cumulatively trained a minimum of 100 candidates with placement of at least 25% of the trained candidates in wage employment, along with a minimum cumulative annual turnover of INR 40 lakh from skill training activities during the last three completed financial years, or a minimum annual turnover of INR 10 lakh from skill training activities in each of the last three completed financial years. The proposals were invited for empanelment with PBSSD for implementation of State-specific Skill Development Training programmes under the Utkarsh Bangla Scheme in West Bengal.

Physical interview scheduled on 09-03-2026, 10-03-2026, 12-03-2026, 13-03-2026 and 16-06-2026, in connection with the empanelment as the National Training Provider & experienced Training Providers (LOI Mode) under Utkarsh Bangla Scheme under PBSSD, West Bengal.

Against the said proposals, the Training Providers as annexed (Annexure A) with this notification are given approval for them being empaneled with PBSSD and for carrying out the state specific short-term training program under Utkarsh Bangla scheme(s) on provisional basis.

Concerned Branch headed by the OSD(UB) shall make sure that the log- in credentials for the training providers shall be created centrally at the State level and their IDs are shared with the successful entities.

The TPs shall the liberty to set up their Training Centers in any of the districts in the State of

West Bengal exercising their choice. The concerned DPMUs having the lawful jurisdiction shall scrutinize the applications for the TC proposals and dispose them off observing extant norms and the due diligence.

In case of discrepancies that are found contrary to the declarations made/ documents submitted at the time of this empanelment at any given point of time the training provider shall be dis-empaneled and necessary penal action will be initiated as per the prevailing protocols and the legal positions.

For any objections/ grievances pertaining to this empanelment the complaints may be lodged by writing to the office of the Project Director, PBSSD.

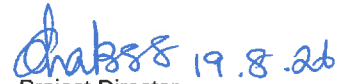
