**NOTICE**

Proposals are invited from empanelled and eligible Training Provider(s) for Short Term Training of already mobilized candidates of various homes under Department of Mass Education & Extension Services, in the job role of Assistant Electrician, Plumber and Garment Manufacturing at prescribed venue at Sarat Bose Road and Thakurpukur in the LOI Model (Third Party Placement Assurance offered by the industries/establishments) of the Utkarsh Bangla scheme under DPMU-Kolkata. Candidates have been identified by the DPMU and all are willing to undertake training. Venue will be provided to the TP after deducting charges as per PBSSD Norms. TP may note that Training in Assistant Electrician and Plumber job roles will be held at Sarat Bose Road, and training in garment manufacturing will be held at Thakurpukur.

**Eligibility Criteria:**

- a. Training Providers(TP) & Training Centre (TC) must be empaneled under Utkarsh Bangla, Kolkata Jurisdiction (i.e Kolkata Municipal Corporation, Bidhannagar Municipal Corporation, Dumdum Municipality & Rajarhat).
- b. They must have experience in training in the above mentioned job roles.
- c. Training provider should be neither blacklisted nor Dis-empaneled any time before from any of the schemes.
- d. No adverse reports/complaints are pending against the TP and awaiting disposal.
- e. None of their trainers have any criminal case pending against them.

Proposals from training providers must be emailed from an official email address to [dpmukolkata@gmail.com](mailto:dpmukolkata@gmail.com) using the official letterhead and including the training details and TC details as specified in Annexure-I. Proposal must also clearly mention which job roles the TP is willing to impart training in and at which location (Thakurpukur/Sarat Bose Road). Along with annexure I, a declaration must be submitted in official letterhead as that none of their trainers have any criminal case pending against them.
